WILLIAMS, BETHANY

Board remuneration approved by members is currently \$380,000 per annum split between 8 directors, which I believe is excessive for a member owned bank which made only \$1m after expenses in 2020-21 and \$156,000 after expenses in 2019-20. If elected, I will be moving a motion that the Board accept a lesser amount than that approved by members, and to reduce Board remuneration year on year during my tenure to a more appropriate amount.

I am not privy to sufficient information to judge whether the decisions of the Board to merge as many times as they have in the last 10 years were the right ones. Perhaps they were, since the legacy of AMBL predecessors have been somewhat maintained. However, I feel with each merger the service to members has declined, and multiple rebranding's have significantly reduced the profit available to reinvest for members' benefit.

An admitted solicitor and public servant, I have 9 years board experience in the highly regulated disability sector. I support stability for existing members and employees, as well as improvement of the online banking application. Notwithstanding mergers, only one new member has joined the Board in the last 10 years. I believe change is overdue.
