



### CUSCAL'S "THE WINNING WAY TO PAY" PROMOTION

### **TERMS AND CONDITIONS**

Participation in the Cuscal's "The Winning Way To Pay" Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions. The promoter is Cuscal Limited (ABN 95 087 822 455) of Level 2, 1 Margaret Street, Sydney NSW 2000 ("**Promoter**").

- 1. The Promotion commences on 1 March 2023 and closes at 11:59pm AEDT on 30 April 2023 ("**Promotional Period**").
- 2. Entry is only open to Australian residents aged 18 years or over who hold a valid personal Visa card issued by a Participating Financial Institution. Winners' companions may be under the age of 18 years.
- 3. Employees (and their immediate families) of the Promoter, Participating Financial Institutions and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 4. To receive one (1) automatic entry into the draw, eligible individuals must complete five (5) separate transactions of over \$20 using their Visa debit card during the Promotional Period and these transactions must be settled within 14 days (each a "Qualifying Transaction").

- 8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

The Promoter may draw additional reserve entries and record them in order in case an invalid or ineligible entrant is drawn. Winners will be notified by telephone and email within two (2) business days of the draw, and their names will be published online at www.cuscal.com.au from 1 June 2023.
- 11. The Promoter's decision is final and no correspondence will be entered into.

  - Attendance at one warm up tour event, to the extent such event is available; Return domestic economy flights from the winners' nearest capital city to each Matilda's FWWC Group match (to the extent required);
  - One (1) night accommodation in Sydney, Brisbane and Melbourne on the day of the match, minimum 4\* and breakfast included; and
  - Visa and FIFA branded Merchandise.
- 13. Spending money, meals (other than the included breakfast at the hotel), insurance, items of a personal nature, in-room charges and all other ancillary costs are not included. Prize must be taken to coincide with the 2023 FIFA Women's World Cup even with flights departing from 20 July 2023 and is subject to booking and flight availability.
- 14. The winners and their companions must depart and return to the same departure point and travel together.
- 15. Itinerary to be determined by the Promoter in its absolute discretion.
- 16. Frequent flyer points will not form part of the prize.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

These Terms and Conditions (and any non-contractual disputes/claims which arise out of or in connection with them) will be governed by the relevant local courts who shall have exclusive jurisdiction over any and all disputes arising out of, relating to or concerning these Terms and Conditions.
